5 ACKNOWLEDGEMENT OF RULES AND GUIDELINES

1. An Oversize Vehicle Parking Permit only exempts a vehicle from "No Parking 2am to 6am; Vehicles over 7' High and 22' Long; Except by Permit" parking restrictions and is only valid on the date written on the permit.
2. Vehicles parked in violation of this parking restriction without a properly displayed and valid permit are subject to citation.
3. You are only allowed to purchase up to 3 one-day permits per day. If you need to purchase more than 3 permits, you are required to submit a subsequent request on another day.
4. Displaying the oversize vehicle permit DOES NOT exempt the vehicle from LAMC 80.73.2, which states "It shall be unlawful for any person who owns or who has possession, custody or control of any vehicle to park that vehicle or leave it standing upon any highway, street or alley for 72 or more consecutive hours."
5. The permit MUST be displayed on the inside of the driver's side window and be readable from the outside of the vehicle.
6. You may display up to 3 permits at a time.
7. The permit must be removed prior to operating the vehicle.
